## Terms of Contract for tea/coffee/water vending machine

- The High Commission will provide suitable space for installation of the aforementioned machine.
- The selected company will be responsible for the transport and installation of the said machine and any charges on account of the same will not be borne by the High Commission.
- A monthly lump-sum fee will be payable by the company on account of electricity charges for the machine.
- The company will be responsible for periodic refilling/repair/maintenance of the machine etc.
- The company will be responsible for ensuring that the products in the vending machine are of good quality, within their prescribed shelf-life and conform to all the safety & quality standards of Mauritius. In this regard the company will also be responsible for periodically removing such items from the vending machines that have already crossed their expiry dates.
- The High Commission of India reserves the right to ask the company to remove the machine, at any point of time, if the need arises without ascribing any reasons for the termination of the contract.
- The period of validity of the contract will be for a year, renewable at the end of the period of contract.
- The High Commission will not be responsible for any damage to the said machine.
